

The Matter and Manual Managerran Mo. + THE MALE Ton 21 Jul 43-1

To: Chief Prisoner of War Control Section.

From: MURATA, Munetaro (村田宗太郎), Chief, Osaka Prisoner of War Internment Camp.

A. Time and Date of Escape.

At about 2200 hours; on 9 Jul 43 the prisoner escaped from the stockade of this internment camp.

B. Sub-Camp Concerned) and Its Location.

Osaka Prisoner of War Internment Camp, Sub-Camp No. 6 HYOGO Ken, AIOI Shi, Aioi Harima Shipyard.

C. Nationality, Rank, and Name of Escapee.

Dutch, Former Naval Ensign UNI Piet Johan, age 30.

D. Capture and Subsequent Disposition (SHOCHI).

At about 1500 hours, on the 11th, it was learned through reports from local Japanese that there was a person who looked like a prisoner of war wandering in the mountains; approximately 15 kilometers north-west of the sub-camp. We rushed to the scene and on the same day, at approximately 2400 hours, the prisoner was captured in the mountains nearby.

At approximately 0900 hours; on the 12th, the prisoner was taken to the sub-camp and an investigation was begun. With the completion of the investigation on 21 July, we set out to retrace the steps of the escaped prisoner UNI, as described in his statement. As the course of the escape was being followed, at about 2000 hours, the prisoner, taking advantage of a possing thunderstorm, suddenly attempted to escape again and was put to death with a military sword.


