NAZI WAR CRIMES DISCLOSURE ACT

KUHARA Fusinosuke

Last Year KUHARA Fusinosuke, as Chairman of the People's Council for the Restoration of Japan-Soviet, Japan-China Diplomatic Relations visited Communist China together with MAJIMA Kan, it's director, DOI Sakenobu (Party member) and OBATA Tadayoshi. In establishing his plans to visit Moscow, KUHARA was first encouraged by DOMINITSKY and later stimulated by the fact that during the Soviet leaders trip to Yugoslavia, MIKOAN had praised KUHARA's skill and ability. However, since the government did not issue the passport required to travel to Moscow, KUHARA decided to visit Peiping for the time being and contact the Soviets in Peiping. KUHARA held two meetings with MAO Tse-tung and talked on the "The Great Asia Principle" and both were completely in sympathy with each other according to KUHARA. At that time the discussion unexpectedly turned to the problem of Formosa and the following points were brought out.

- a. Withdrawal of U. S. troops.
- b. Cooperation between Nationalist and Communist Chinese.
- c. The building up of Asia centered on Japan and Communist China.

KUHARA returned to Japan at the beginning of fall, 1955, and following this carried out very active but extremely secret activities using the People's Council for the Restoration of Japan-Soviet, Japan-China Diplomatic Relations as a foothold and working upon the Conservative Party through his son-in-law ISHII Mitsujiro (Chairman of the Liberal-Democratic Party Executive Committee), on the Socialist Party through KAZAMI Akira and upon the newspaper circles through KANO Chikao, Chief of the Editorial Bureau of MAINICHI Shimbun. At present, he has close liaison with TICHIVINSKY and has a thorough knowledge of the Soviet Far Eastern policy more so than anyone else in the Japanese Government circles. The reason why he has such close feelings with the Soviet is because he considers the Russians to be part of the Asiatic people. Recently when the Communist China Sample Fair was held in Japan KUHARA maintained contact with AIKAWA Yoshisuke (KUHARA's brother-in-law), Chairman of the Japan Medium and Small Enterprise Council and issued various directives which included various suggestions. Eventually when they expressed a desire to extend their stay in Japan he worked upon the governmental circles to see what could be done (Minister of International Trade and Industry ISHIMASHI Tanzan, etc.). Funds were turned over to him when Madame LI, Communist China Fair Delegation, and the Peiping Drama Troupes visited Japan.

He is working on the unification of the National and the Communist Chinese through HAYAMI Chikashige (2483/6015/6024/6850), a soldier of fortune who formerly lived in China (approximate age 28, graduate of DAI SHITCHI Higher School and Kyoto University. No fixed employment. During the war he was persecuted by TOJO and went to China where he was in charge of a Japan-China Peace Operation. He was close to KONOYE). KUHARA is working on this as if it is his last mission on earth. In order to strengthen the ties with CHIANG Ching-kuo he was actively working through HAYAMI and HSIEN Man-kuang (6200/0589/0342) (former member of the Chinese Mission, later a member of the Chinese Communist Party).

HATOYAMA Ichiro's recommendations in the formation of a racial front were handed to KUHARA, who was an important figure in the SEIYUKAI when HATOYAMA was a member of that party. It is believed that after the large-scale depurge, KUHARA's former followers in the SEIYUKAI will join the HATOYAMA faction...MATSUMO Tsuruhei's supporters in the present Liberal Party who were also affiliated with the KUHARA line in the SEIYUKAI include SATO Eisaku and YAMAZAKI Takeshi. 22 Jun 51

KUHARA Fusinosuke

Former president of now defunct SEIYUKAI, once the most powerful political party in Japan, became member of YOSHIDA's Liberal Party 3 Nov. KUHARA, who was purged after Japan's surrender as Japan's political leaders, reinstated 2½ months ago when the Japanese Government was given authority by SCAP to conduct a mass depurge. His affiliations with the Liberal Party reportedly made at the request of Premier YOSHIDA himself (FBIS, 5 Nov 1951; CENTRAL NEWS, Tokyo)

On 22 May 1948 the Purge Appeals Commission rejected the appeal of KUHARA Fusinosuke, a leader of the defunct Seiyukai Party.

There is evidence that Communist Party leaders at least have tried to effect liaison with some of Japan's most notorious rightists. KUHARA Fusinosuke, friend and financial supporter of right-wing military groups that forged Japan's foreign policy through violence and threat in the 30's, was approached by three top JCP leaders for an interview shortly after the Americans released him from Sugamo Prison where he had been held as a war criminal suspect.

KUHARA turned them down, saying "the time is not yet ripe", but later he told this correspondant that in the final showdown the leaders of the JCP would "act like Japanese first, then like Communists". The great bulk of the new ultra-nationalist societies are small groups of men who served together in the war.

Extract from CIS/FEC Special Report, THE BROCADE BANNER, THE STORY OF JAPANESE NATIONALISM by Tom Davis, 23 September 1946 (OSO Registry #44-7-8-1)

KUHARA speaking in February 1928: "The Cabinet's most important mission at this time is the solution of the Manchurian and Mongolian question. Now is the time to solve the question of Manchuria and Mongolia. In this lies my reason for having supported TANAKA all these years. I shall be able to do much if I become the Vice-Minister of Foreign Affairs, because TANAKA is Foreign Minister as well as Premier. If necessary, I am willing even to become a consul general in Manchuria."

KUBOTA Kinshiro stated in his testimony at the time of the investigation of the 26 February 1936 Plot, that KUHARA was in favor of making Manchuria an unarmed free state, just as Korea should have been. Japanese control, he implies, would have been exercised through economic and other unofficial means.

Report implies JCP leaders were interested in developing liaison between JCP and rightists. Subject told them "the time was not yet ripe". Later Subject remarked to source that in final showdown JCP leaders would act like Japanese first, then like communists. 13 Aug 48, from news article by Howard Handleman, INS correspondent

1949 - Named among friends of WANG Wen-cheng who arrived in Japan and was believed to be seeking help from Jap financiers in organising and financing a Japanese volunteer corps to strengthen TANG En-po's army and to organize trade corp to give economic assistance to TANG. 16 May 49.
Note: China desk was queried on activities of WANG Wen-cheng. WANG belongs to an anti-Chiang Kai-shek clique which is suspected of having ties with Peiping although no data has been produced to establish this. They are opportunists.

WANG Wen Cheng (alias WANG Shih Ching) has again come to Japan and is living in Hayama, Kanagawa-en. It is reported that his visit this time is in connection with TANG En Po, General in command of the Nationalist 3rd Army, and LUNG Tso Liang, alleged Chief of Staff to TANG En Po, who has come as an aide of WANG's. WANG graduated from the Quartermaster School of the Japanese Army in 1906 and then entered the financial field in China. In 1938 he was appointed president of the Japanese supported Federal Reserve Bank in China and Chief of the Financial Section of the North China Provisional Govt. Because of his background, WANG has numerous friends among the former leading Japanese financiers and businessmen, such as KUHARA Fusanozuke and AYUKAWA Gisuke and FUJIMANN Aichino. It is being rumored in well-informed Japanese circles that the mission of WANG is to obtain the help of Japanese businessmen and financiers to organize and finance a Japanese Volunteer Corps to strengthen TANG En Po's army and to organize a trade corporation to give economic assistance to TANG En Po.

15 Sep 50, ZJLA-1169 quotes SHINSO No. 16, 15 Feb 50: Connects KUHARA with WANG Tsu-hui (possibly alias for WANG Wen Cheng or vice versa). WANG is

a. KUHARA Announces Plan: KUHARA Fusinosuke (INTSUM 3433), who is engaged in attempting a political comeback, has prepared a plan entitled "A New Statecraft for a Difficult Age." He will circulate this as widely as possible and hopes to have it printed completely in the "Nippon Times" within the next few days. (c)

Comment: The plan calls for Government investment in private industry by the purchase of shares, but without participating in management. The plan contains nothing new, but is of interest because of its propounder—a fabulous prewar figure, now 83, who was at the same time a top professional politician and also a minor zaibatsu (INTSUM 3357). On the political side, he was Communications Minister under TANAKA Giichi in 1927, four times elected to the Lower House, president of the Seiyukai Party (ancestor of the present Liberal Party) in 1939-1940, and a member of the Cabinet Advisory Council several times. As a business man, as president and principal owner of the KUHARA Mining Company, he practically controlled Japan's copper output, and had many other business interests as well. He is laying the ground to run in the next general election from Yamaguchi Prefecture.

There exists no particular or definite relationship between the two. If there is any rumor going around in the world that these two are connected, it is attributable to the fact that FUKUYA Shunichi has taken IWAKURO two or three times to KUBARA's home and introduced him. KUBARA has practically no concern today with the armament issue nor with any other military affairs. Since KUBARA contemplates participation in the formation of a new political party with FUKUYA and other IWAKURO associates, FUKUYA took IWAKURO to KUBARA with the thought that KUBARA should gain a general picture of military planning and an up-to-date general knowledge of military affairs. FUKUYA had IWAKURO explain about current military affairs to KUBARA. IWAKURO has previously been on duty with the Military Affairs Bureau, War Ministry for a long time. FUKUYA merely asked IWAKURO to inform KUBARA of the facts he knew himself to be true. Although KUBARA has become acquainted with IWAKURO and thought well enough of him but he paid not particular respect to IWAKURO nor did he attach any lasting significance to his relationship with IWAKURO.

A ~~SECRET~~ SOURCE article dated 23 March (very valuable), and entitled "Japanese War Plans Director Reidsi Suspected as a War Criminal" (for Japanese Criminal Unit File, Reidsi Suspected) is quoted as follows:

YOSHIOKA was once Prime Minister and is sixty-seven years old. He first entered the GHQ-1004, an ultra-nationalistic body, as a follower of TOKIO SHIBATA and became closely associated with SHIBATA later. He established the so-called "Military Reconstruction Department" and says it was he who recruited the Japanese former Anti-Communist Party for Japan into GHQ-1004 (he then became Director General of GHQ-1004). He remained with GHQ-1004 until the time of the Japanese peace agreement. He was detained by Soviet Russia from 1945 to 1948 as a Class "A" war criminal suspect immediately after the war but was later released. He is now living in a big mansion at Ojiyama in Tokyo.

GHQ-1004, former Prosecutor for the Tokyo District Court and present (as of 1946) Prosecutor of the Tokyo District Court, was interviewed at the offices of the Tokyo Prosecutor on 10 December 1955. When questioned with regard to the Japanese sources of funds, GHQ-1004 stated that he believed that SHIBATA, SHIBATA, GHQ-1004 Prosecutor, and AIZAWA Tadashi were his principal business and that they turned to various business interests through TOKIOKA in connection, as well as valuable advice and information from him.

Tokyo, Aug. 17—Fusanosuke Kuhara, 86 year old veteran politician, left with three members of his team late lastnight by Japan Air Lines plane for Communist China on a "national good will mission." Kuhara, known as the "sphinx" of Japan's political circles for his grandiose ideas, is chairman of the national council for restoration of diplomatic relations between Japan and Communist China and Japan and the Soviet Union. The party included Teiichi Nishikawa, mining company executive and former progressive Government economic leader, and Kuhara's son and daughter. The quartet will join two other members of the party who had left ahead of them in Hong Kong and tour Communist China for about 2 months. The Japanese Govt refused permission for the Party to visit the Soviet Union from Red China as Kuhara wished. Kuhara, however, reportedly was planning to see Soviet Deputy Premier Anastas Mikoyan at Peking. He is said to have wired Mikoyan to come to Peking for the meeting.

Kuhara, clad in Japanese kimono, said at the airport that he has been interested in China since helping Sun Yat-sen, the late Chinese revolutionary leader, 40 years ago, and he hoped to promote Japan's reconciliation with both Russia and Red China.

He refused to say whether he would meet Mikoyan at Peking, but added in his usual mysterious way: "I go to any place where man is."

(Editors note: A KYODO Aug 17 Noon Edition dispatch from Hong Kong reported that Kuhara, upon reaching Hong Kong Aug. 17 said that it was still not known whether his party would extend ~~it~~ its trip to Russia from Peking; that it all depended upon whether his group was asked to do so or not. He said if he visited Soviet Russia, he would discuss the peace issue freely, as a civilian.)

The old man KUHARA is a great realistic politician. When he wants to put his thoughts into practice, he uses whatever means appropriate for the purpose. MATSUNO Kakuhei once said, "When I am with KUHARA, he prospers as he steps on right road; but when I am not with him, he does not prosper, as he walks on dark road."

I contributed to the Tokyo Nichinichi on the 23rd March this year, giving what I heard from him:

"These days, politicians and major people are outside themselves. They think Japan will be attacked unless it sides with America or China and Soviet. It is absurd. No one can attack Japan if it stands erect."

"Trading and cultural exchange with China and Soviet are quite natural. China, Soviet and Korea can only be very adequately exploited by Japanese people. Siberia, Karafuto, Manchuria and Mongolia, forest, pulp, railways, road construction, copper mine, fishery are all fit for Japanese."

"Japan has not been invaded for 3,000 years. If it is occupied and administered forcibly, it will never yield. Any one who invades will be betrayed by the people. Lack of pride and dignity is the cause of being fooled."

The old man's talk appeared on the Tokyo Nichinichi saying, "When I was at Kosaka mine, I thought of killing and throwing into the depth all officials, police or tax-men who ran counter against me." He said also on a hot day just before departure, "It is awfully hot and sleepy."

1. KUHARA Fusanozuke¹ is in close touch with Sergei L. Tikhvinckiy, head of the Soviet Fishery Mission in Tokyo.²
2. While the Chinese Communist sample fair was in Japan during 1955, KUHARA was active in contacting Government personnel to attempt to arrange for the Chinese Communists to extend their stay, as they wished to do.³ KUHARA contacted, among others, Minister of International Trade and Industry ISHIRASHI Tanzan.
3. KUHARA received funds from the Chinese Communists both when Mao LI Te-ch'ien was in Japan in November 1954 and when the Chinese dramatic troupe headed by MEI Lan-fang was in Japan in 1956.
4. KUHARA is working for the unification of Communist and Nationalist China through HAYAMI Chikashige (2483/6015/6830), a soldier of fortune (sic) who formerly lived in China,⁴ through whom KUHARA is trying to strengthen his ties with CHIANG Ching-kuo.⁵

1. Field Comment. The 87-year-old KUHARA is a somewhat equivocal figure on the Japanese political scene, variously reported to be influential behind the political scenes and to be an eccentric dotard whose views are disregarded by political leaders. KUHARA headed the Seiyukai before and during the war but has not returned to active postwar political life since his depurge. He is Chairman of the People's Council for the Restoration of Relations with China and the USSR (Nitchu Nissei Kokko Kaifuku Kommin Kaigi).

2. Source Comment. KUHARA has a more thorough knowledge of Soviet Far Eastern policy than anyone in the Japanese Government. KUHARA considers the Russians as an Asiatic people and so feels close to them.

3. Field Comment. KUHARA's efforts were apparently fruitless.

4. Source Comment. HAYAMI is a graduate of Kyoto University. During World War II he was persecuted by YOJO Hideki and went to China, where he was in charge of an operation designed to bring about peace between China and

Japan; he was close to Prince KUNO Fumimaro.

5. Source Comment. According to informed sources close to Communist Chinese and Soviet circles in Tokyo, it is common knowledge that the Chinese Communists are working on CHIANG-Ching-kuo to bring about cooperation between Communist and Nationalist China. It is believed that overtures to CHIANG are being made by reporters for the Chinese Communist newspapers Jen Min Jih Pao and Ta Kung Pao via Peiping and Hong Kong. Overtures are also being made to KUHARA Na-ting-hsi (1313/4382/3056) and YEN Hei-chan (705/6932/1472).

Field Comment. The above Comment appeared in the same original report as the other information above, and no direct connection was indicated between the above approaches to CHIANG and the activities of KUHARA. However, since the objective is the same and in both instances CHIANG is cited as the target of the approaches, it may be inferred that Source feels the two reported activities to be connected. Source also stated that KUHARA was trying to strengthen his ties with CHIANG by working through HAYAMI and HSIEH Nan-kuang, a Chinese Communist official who defected from the Chinese Nationalist Embassy in Tokyo, but if there is any truth in the above it would appear logical that HSIEH would be using KUHARA and HAYAMI as a channel to CHIANG rather than that KUHARA would be trying to get to CHIANG through HSIEH.
